After Close of the Public Hearing

Chairman Murphy: Public hearing is closed; Mr. Ulfelder.

Commissioner Ulfelder: Thank you, Mr. Chairman, This is a fairly simple and straightforward comprehensive sign plan amendment for the – for the Dulles Suburban Center, one of the buildings there. Now that EADS North America and Airbus Americas have been reorganized into one, we'll be eliminating two signs going to one single sign, but leaving in some flexibility with one of the new conditions to - - if there's an additional tenant – to go back to the current situation. But with the one sign, it will actually be taking up less sign area as well on the building. So, with that, Mr. Chairman, I WOULD LIKE TO MOVE THAT THE PLANNING COMMISSION APPROVE COMPREHENSIVE SIGN PLAN AMENDMENT CSPA 86-C-029-10, SUBJECT TO DEVELOPMENT CONDITIONS DATED APRIL 29<sup>TH</sup>, 2015.
